At these events, the following titles are awarded:

## - Worldshow:

The winning dog and female in youth class (9 – 18 months) :

IFR youth World Winner (year)

 The best dog and female chosen from the first placed dogs (on condition they are qualified as Excellent) in intermediate, open, working and champion class:

IFR - World Winner (year)

## Worldchampionship IPO III ABC :

The winner of the individual competition: IFR Worldchampion (year).

We dare to ask you to officially recognize these titles granted by our International Federation of Rottweilerfriends.

Such recognition by the FCI would greatly contribute to the importance and influence of these titles and, very importantly, would enable us to ask FCI-affiliated national kennelclubs to also recognize these titles and to mention them on the pedigrees of the concerned dogs and descendants.

It goes without saying that this would also be an important support of our international efforts to improve the breeding, keeping and education of the Rottweiler as the breed is defined by the FCI-breed standard nr. 147.

I thank you for the attention that will be given to our request and look forward for your answer.


